



## Food Truck Naming Competition - Terms and Conditions

#### 1. Prize:

We're inviting the community to help name our Food Truck on the Village Green! Submit your best name idea (using appropriate language, of course) for a chance to win \$250.

#### 2. Eligibility:

The competition is open to everyone.

Employees of NHHA are not eligible to participate.

All entries must be original and created by the person submitting them.

#### 3. Entry Submission:

Limit of one (1) name suggestion per person.

Entries must be original, use appropriate, family-friendly language, not include offensive, defamatory, or inappropriate content, and must not infringe upon any third-party rights, including copyright or trademark.

Entries must be submitted electronically through the link by 5pm Sunday 15 February 2026 deadline.

Each entry must include the following information: Your name, email address, contact number, the proposed Food truck name and a brief explanation of the idea behind the name (maximum 100 words).

#### 4. Theme:

The name should suit a Food truck located on the Village Green, be welcoming, fun and community-focused and appeal to a wide audience.

Entries that do not align with the theme may not be considered.

#### 5. Judging Criteria:

All valid entries will be reviewed by a judging panel.

Entries will be judged based on creativity, originality, relevance to hockey, and the overall suitability as a food truck name.

The decision of the judging panel is final, and no correspondence will be entered into.

The judges will select the top five (5) entries to be voted on by our community.

#### 6. Community Voting

The community will be able to vote for their favourite name from five (5) chosen by the judges.



Community voting is open from Friday 20 February at 5pm and closes on Sunday 1 March at 5pm.

**7. Prize:**

The winner will receive a prize of \$250 cash.

The prize is non-transferable and cannot be exchanged for any other alternative.

**8. Intellectual Property Rights:**

By participating in the competition, participants grant NHHA the full and exclusive right to use the winning name for all purposes, including brand and marketing.

The winning name becomes the property of the organiser.

No further compensation will be provided beyond the prize.

**9. Disqualification:**

The organiser reserves the right to disqualify any entry that breaches these Terms & Conditions, contains inappropriate language or content, is copied or infringes on third-party rights, and is submitted fraudulently or dishonestly.

**10. Announcement of Winners:**

The winner will be announced on Tuesday 3 March at 5pm through NHHA's official communication channels.

The winner will also be contacted directly using the details provided.

**11. Privacy Policy:**

Personal information will be used solely for administering the competition.

Information will not be shared with third parties without consent.

**12. Modification or Cancellation:**

The organiser reserves the right to modify, suspend, or cancel the competition at any time without prior notice.
